Austin-based **RPM Living** purchased Ashton on West Dallas, a 246-unit apartment community at 1616 W. Dallas in the Montrose area, from CIM Group. The property was developed by Alliance Residential and opened in 2013. Amerant Bank provided financing.

Houston-based Fein acquired 13.4 acres to develop the Terrace at Pine Lake Cove Apartment Homes, a 241-unit garden-style community just south of the intersection of South Pine Lake Road and Highway 105 in Conroe. The community of two- and threestory units will range from 556 square feet to 1,773 square feet with up to three bedrooms. The property, located within Montgomery ISD, will have views of Lake Conroe and a resort-style pool with poolside cabanas. Planned amenities include a club area with fitness center, a separate yoga/training/spin studio, billiards table, flatscreen TVs, a golf simulator and virtual game room, a library and conference room. Steinberg Dickey Collaborative provided architectural services while Moore Design Group of Dallas provided interior design services. Westchase Construction, an affiliate of Martin Fein Interests, will be the general contractor. Cameron Cureton of JLL arranged equity financing from Nationwide Insurance. Comerica Bank is provided construction financing. Planned for completion in the fourth guarter of 2024, the development is part of Pine Lake Cove, a 300acre community planned for up to 865 homes by Meritage Homes. Founded in 1989, Martin Fein Interests has developed

approximately 13,000 luxury apartments in the southern U.S.
